It is by the divine grace of God, wisdom, and understanding from above that we have been able to walk through this spiritual year. We give thanks for His continued guidance and provision in the ministry.

Achievements

- 1. Successful launch of Wanga TTI Fellowship into our membership structure.
- 2. Revival and strengthening of Regional Coordinating Committees (RCCs), enhancing regional outlook and fellowship engagement.
- 3. Smooth leadership transitions across various fellowships, promoting stability and continuity.
- 4. Bridging the gap between fellowships and the secretariat through consistent visits and participation in regional special events.
- 5. Improved conflict resolution mechanisms within fellowship leadership, aided by RCCs and the secretariat.
- 6. Follow-up on the Maasai Mara Weso Fellowship is on course for its official launch.
- 7. Strengthened fellowship operations under the CUs through training and stakeholder engagement under the ET-CU Caucus.
- 8. Appointment of caretakers, who have provided crucial support and positive influence in fellowships such as Kikuyu and JKUAT.
- 9. Development of individual fellowship guidelines, aligned with the broader Ministry Constitution.

Setbacks

- 1. Financial constraints limited the ability to physically attend to some ministry activities.
- 2. Increased tensions between some fellowships and their mother CUs, notably at Moi University.
- 3. Breaches in ministry communication protocols.
- 4. Low member turnout in some fellowships, such as Kenya Science.
- 5. Instances of fellowship leaders distancing themselves from ministry policies.
- 6. Poor financial reporting and mismanagement in some fellowships.

Recommendations / Way Forward

- 1. Increase interaction with Alumni groups to enhance mentorship, guidance, and financial or moral support.
- 2. Encourage all fellowships to open bank accounts under the ministry's name with an introductory letter to ensure proper financial management.
- 3. More leadership trainings to promote adherence to ministry policies and the realization of the Kingdom agenda.
- 4. Support for the National ET leadership to ease existing tensions between the CUs and fellowships.
- 5. Engage all caretakers and patrons, ensuring they are part of fellowship planning and management processes.
- 6. Fast-track the official launching of the Maasai Mara Weso Fellowship to consolidate ministry growth.

Conclusion

As we continue to serve, let us all take ownership of this ministry through unity in our fellowships. Together, let us build the body of Christ in our institutions as faithful stewards of His calling.
